

About Us

GFAS' mission: to accredit and recognize sanctuaries and rescue centers, support them to achieve the highest Standards of Excellence, promote collaboration, and raise awareness of their work.

GFAS currently supports 210+ sanctuaries located within the U.S. and throughout 18 countries, worldwide.





For GFAS, an animal "sanctuary" is a facility providing temporary or permanent safe haven to animals in need.

This includes:

- ✓ Equine transition centers
- Equine sanctuaries
- ✓ Wildlife sanctuaries giving lifetime care
- ✓ Wildlife rehabilitation facilities that release animals
- ✓ Farmed animal sanctuaries and rescue centers



- ✓ Must have non-profit status
- ✓ No direct contact with wild animals
- ✓ No commercial trade of animals or animal parts
- ✓ No breeding unless part of a bona fide breeding for release program
- ✓ No invasive research





- In addition to eligibility requirements, facilities must meet GFAS <u>Standards of Excellence</u> in areas of animal care and operations.
 - Operations Standards contain guidelines for non-profit governance, finance, staffing, safety and education/outreach.
 - Equine Standards contain guidelines for animal housing, nutrition requirements, veterinary care, and adoptions and fostering.
- GFAS accreditation is not a pass/fail process. Rather, application to GFAS and action items to come into alignment with GFAS Standards are a self-evaluation and learning process.





Maintaining Standards

Working closely with our member sanctuaries, we improve animal care and ensure best practices and compliance.



VERIFICATION and ACCREDITATION

Both involve the same level of assessment in areas of equine housing, veterinary care, nutrition, and well-being, with Accreditation also putting greater emphasis on governance, financial planning, and risk management including:

- Formal strategic and succession plans
- Long term financial plan and greater financial reserves
- Training and supervision manuals for employees, volunteers and interns

Both Verification and Accreditation require site visits.
